



AGM RESOLUTIONS

WE, THE PARENTS OF PPS, AT THE AGM HELD ON THE 2ND OF NOVEMBER 2019 AT PRINCESS PRIMARY SCHOOL HALL ,

NOTED THE FOLLOWING:

- That the school is performing very well academically
- The school is well resourced and well maintained
- The school has been surviving on the financial reserves for the past 4 years
- That most of the parents are not paying school fees but expect quality education for their children, they are parasites of the sweats of other parents, they continue to live a lavish life and ignore paying fees for their children
- Parents owing school fees deliberately do not attend meetings
- The school has SGB employees to match the skills and scope of work
- The school needs financial stability urgently

Believing that:

- The school has the capacity to collect fees
- The parents payment of fees will make the school sustainable
- Parents chose PPS knowing that it is a fee paying school
- If parents do not pay fees, the school will retrench all SGB employees and surrender all top class resources to the service providers - Leaving the school in dire stress, degradation of highest proportion. (Lowest Class Education)
- Retrenchments of SGB employees will lead to overcrowding of classes (70 – 80 learners per class) and poorly maintained school
- All Parents have a role to play for the betterment of the school

Therefore resolve that:

- Pps must screen parents before accepting their children in the school

- The SGB / PPS must not enrol or accept learners whose 2019 school fees is not paid in full and inform the district to place these learners in a no fee paying school. (These parents who are owing fees are able to pay and never requested school fees exemption, they are not willing to pay fees - they must send their children to a no fee paying school)
- All parents, current and new, must sign acknowledgement of debt (**AOD**) being for school fees 2019 / 2020 with immediate effect. This is mandatory to all parents. The school should provide a list of parents who are not cooperating in this regard.
- The SGB must issue report cards to Parents and ensure school fees is collected.
- For learners to participate in programmes such as Excursions, Farewell, etc where in parents chose to pay for such and ignore school fees, The School fees account must be up to date for a learner to participate.
- All outstanding school fees for this year, must be settled by end of November 2019
- No one should live a lavish life at the expense of the other, all parents owing school fees must be **prosecuted** , **handed over to debt** collectors and also **blacklisted**
- Parents who are not willing to pay fees - Must remove their children from PPS and send them to a NO- Fee Paying School or a Private School of their choice.
- Learners whose parents owe fees, will not receive Awards items (Trophies, Certificates, Badges, etc) which are paid for, by other parents - In this Case, Parents Must pay school fees and or sign AODs.
- All parents should complete a Debit order instructions. This is mandatory to all parents. The school should provide a list of parents who are not cooperating in this regard.
- All Exempted parents must show active participation towards taking the school forward by purchasing a tablet, which comes with benefits for parents, learners and school to offset expenses and also offer voluntary contributions and service to the school
- The School fees for the Academic year 2020 shall not be Increased (**R7830.00**). The SGB must rigorously pursue parents who are owing school fees
- All parents must Re- Register their children with the Amount of **R2000.00** by end of December 2019. All parents who fail to re-register their children should be flagged as a high risk to the school .
- All Learner Report cards should be collected by parents, and School fees must be settled. **NO EXCEPTIONS. (All 4 school Terms)**

- School Fees for each Year must be settled within 10 Calendar months of the same Academic year.
- The SGB and school leadership to intensify all school programs and ensure that the school is sustainable - Revisit Strategic Document, School Policies, SGB Program of Action and Whole School Development Planning to coordinate events for the current Academic year and years to come
- The SGB and School Leadership to conclude all outstanding projects : Completion of Lapa, Tiling of Media Centre, Classes , etc depending on the health of the school account
- The SGB and school leadership to Continue with the whole school maintenance and provision of quality education of an African Child
- PPS parents will continue to support the school in all fundraising activities – Civvies, Fun Day, Cultural Day, Valentines Picnic, Excursions etc
- PPS parents endeavour to sustain all the standards of the School, will stand united to defend any downfall of the school as a result of uncooperative parents.
- The Budget review meeting must be held in March 2020 where in parents school fees payment must be displayed for all to see.
- PPS parents will not tolerate to carry any parent who is not paying school fees whilst the same parent is bale to pay.
- **DISCOUNTS APPLICABLE ON SCHOOL FEES 2020 (R 7830.00) NO INCREASE**
 - If fees for 2019 is settled and a tablet paid: school fees for 2020 SHALL BE : R 6030.00 for ten months. (January – October 2020)
 - If full school fees for 2020 is paid by end of January 2020 - 10% discount on the R 6030.00 school fees
 - If full school fees for 2020 is paid by end of February 2020 - 7.5% discount on the R 6030.00 school fees
 - If full school fees for 2020 is paid by end of March 2020 - 5 % discount on the R 6030.00 school fees
 - NOT DISCOUNT APPLICABLE FROM APRIL ONWARDS
- **ALL PARENTS WHO WERE GRANTED EXEMPTION IN 2019, THAT EXEMPTION IS NO LONGER APPLICABLE IN 2020. THEY MUST COMPLETE A NEW APPLICATION FOR SCHOOL FEES EXEMPTION.**
